## **Your Cashback Entitlement**

Congratulations! ### A. About Us

We are Cashback America Inc., a Florida corporation whose address is 5449 South Semoran Blvd., Orlando, Florida, USA and we specialize in the creation and administration of sales and marketing promotions.

### B. About the Promotion

3. You must exercise your right to claim by mailing this original Cashback Voucher to USAS, at the Administration Address. This must be postmarked no earlier than the end of the eleventh month after the Issue Date and no later than the 30<sup>th</sup> day after the end of the the eleventh month after the Issue date, together with:
